Each concessionaire is required to have a **Certificate of Insurance** showing a Comprehensive General Liability policy and Standard **Colorado Worker's Compensation**.

All concessionaires are **required** to complete the **City of Grand Junction vendor qualification approval process** no later than July 1, 2025. No concessionaire will be allowed on site without approval. Visit www.gjcity.org/638/Approved-Food-Vendors for more information.

Each vendor is required to have a special events license from the Colorado Department of Revenue. You can apply online at www.tax.colorado.gov/file-special-event-sales-tax-online.

Deposit: There is a refundable deposit of \$125 payable at the time of the application. Deposits will only be refunded if the vendors meet all requirements stated in the 2025 Mesa County Fair Information and Regulations brochure. No Application will be accepted without the deposit.

Rates: are determined by the space they require.

- 20' x 30' booths are \$700
- 15' x 35' booths are \$500
- 10' x 10' booths are \$150/ 10' x 10' Food booths are \$300

Vendor may now choose to be on site 3 days (Thursday, Friday and Saturday) or 5 days (Tuesday, Wednesday, Thursday, Friday and Saturday). Set up times will be limited to 2 hours before the Fair opens for those who choose 3 days.
